

Campground Opening:

Seasonal Campers:

- May 2nd thru September 28th, 2020.

Short-Term Campers:

- May 29th, 2020. Guest/Visitors may enter (as always, you are responsible for your guests, and bringing them up to speed with Acorn Campground policy and guidelines.)
- June 1st, 2020 for self-contained units only.

Campground Amenities:

OPEN

- Outhouse/bathroom across from office. We encourage everyone to use their own bathroom to limit exposure. If you do use, please wash your hands after use.
- Laundry - Your safety is our #1 concern.
 - 2 customers maximum at one time.
 - You must practice social distancing and wear face coverings while in the laundry room.
 - You can be in the laundry room to load and unload machines only, in order to make room for the next guest.
 - Please wait outside or in your car while clothes are in machines.
 - Washers provide cold water only.
 - We will be cleaning/disinfecting daily.
- 3rd Bathhouse opened June 5th, 2020 - Your safety is our #1 concern. This bathhouse will remain open, but due to COVID-19, we encourage everyone to use their own bathroom/shower, if possible, to limit exposure.
 - 4 people maximum at one time.
 - Practice social distancing and wear a face covering while in the bathhouse (not in the shower).
 - Take care of business and depart the bathhouse. Do not linger.
 - Daily cleaning/disinfecting protocols are in place.
 - Please report any issues to the office.
- Office/Store – opened Friday June 5th, 2020. You must wear a face covering to enter.
- Pool – opened June 22nd, 2020.
- Playgrounds & basketball court – opened July 2nd, 2020.
- Game Room & restroom – opened July 3rd, 2020.

CLOSED

- Bathhouses # 1 & 2
- Water and Electric sites

COVID-19/Health Policies:

You can enter Acorn Campground if you are healthy:

- Individuals who have recovered from COVID-19 and waited the CDC recommended amount of recovery time.

You cannot enter Acorn Campground if you have the following:

- Anyone showing symptoms of COVID-19.
- Individuals exposed to COVID-19 and not showing symptoms must wait the CDC required 14-day period of no-symptoms in order to enter Acorn Campground.
- People who develop symptoms while staying in Acorn Campground need to proceed to their primary residence. Our entire county has one hospital and they may not be able to handle an influx of COVID-19 patients.

Policies for camping in Acorn Campground under COVID-19 restrictions:

- Groups/gatherings up to 500 people in an outdoor setting (socially distanced and wearing face coverings).
- Social distancing of 6 feet is mandated in the campground.
- You must wear a face covering when inside campground facilities and when interacting with people outside of your campsite, when you cannot social distance 6 ft. Walking/biking the campground with a face covering is not required. If you choose to stop and interact with people, then a face covering is suggested.
- As usual, all individuals in the campground must be able to remove themselves from the property at any time. In other words, everyone must have a vehicle on site and the ability to depart the campground in their vehicle.
- It is in your best interest to bring supplies with you. Local stores here have limited supplies on hand.

Travel Advisory: Under the 14-day quarantine travel advisory announced by the Governors of New Jersey, New York and Connecticut, individuals traveling to or returning to NJ from states with increasing rates of COVID-19 are advised to self-quarantine for 14 days. This includes travel by train, bus, car, plane and any other method of transportation. As of Tuesday July 14th, there are currently 22 states that meet this criteria: Alabama, Arkansas, Arizona, California, Florida, Georgia, Iowa, Idaho, Kansas, Louisiana, Minnesota, Mississippi, North Carolina, Nevada, New Mexico, Ohio, Oklahoma, South Carolina, Tennessee, Texas, Utah, Wisconsin. <https://covid19.nj.gov> for an update every Monday.
